

## Secret Sound Game Contest Rules

1. US92 Radio – KUSO-FM, Albion-Norfolk (hereinafter referred to as “US 92”) is playing the Secret Sound Game from October 1<sup>st</sup>, 2015 until the current jackpot is won during the week of October 26<sup>th</sup>, or until October 31<sup>st</sup>, 2015.
2. The Secret Sound Game will be played 4 times each week day. On October 1<sup>st</sup>, the jackpot will start at \$500. Up to a :02 second clip of the Secret Sound will be played and contestants will guess what the sound is.
3. Qualification for the contest begins at 7:00am on Thursday, October 1st, 2015 and until a winner guesses the Secret Sound during the week of October 26<sup>th</sup>.
4. Four (4) Listeners will be qualified each week day. To become a qualifier, you must be 19 years old and:
  - a. Be one of three (3) callers that were caller number 9 after the cue to call is given, or
  - b. Have provided your name, phone number, city and age to be considered as a Shout Out Contestant. Shout Out Contestants will be randomly selected and will be called by a US92 DJ.
    - i. If the first Shout Out Contestant does not answer, up to 2 more calls will be made in attempt to get a Shout Out Contestant.
5. All contestants must provide a guess to become a contestant in the Secret Sound Game.
  - a. If contestants correctly guess the Secret Sound they will be awarded the current jackpot.
    - i. Cash Prizes will be paid on the next 11<sup>th</sup> or 21<sup>st</sup> of the month.
  - b. If a contestant incorrectly guesses the Secret Sound they will receive a consolation prize and the jackpot will grow by \$25.
  - c. If a Shout Out Contestant incorrectly guesses the Secret Sound they will receive a consolation prize and the jackpot will grow by \$50.
6. The game will be played and the jackpot will grow until someone correctly guesses the Secret Sound.
7. If the Secret Sound is guessed on or before October 28<sup>th</sup>, the jackpot will start over at \$500.
  - a. If the Jackpot is guessed after October 28<sup>th</sup>, the game will be over.

8. An incorrect guess list will be available on us92.com.
9. These rules may be amended from time to time at the sole discretion of US 92.
10. No person shall win more than one US 92 prize in 30 days.
11. Winner of the contest shall be required to complete any and all documents at the request of either US 92.  
Winner also shall give their Social Security number to US 92 for tax reporting purposes.
12. Any person who calls in or is a Shout Out Contestant consents to US 92, Flood Communications, LLC.  
and its sponsors to use his or her name in recorded audio for play back.
13. Any attempt to tamper with the entry process, interfere with these Contest rules, deliberately damage any website or undermine the administration, security or legitimate operation of the Contest, is a violation of criminal and civil laws, and US 92 reserves the right to seek damages and/or other relief from all persons responsible for such acts to the fullest extent permitted by law, which may include banning or disqualifying entrants from this and future US 92 contests.
14. US 92 reserves the right, at its sole discretion and without prior notice, to amend, cancel, close, suspend or reinstate a contest at any time and for any reason whatsoever. US 92 reserves the right, in their sole discretion, to cancel or substitute any component of a prize for its cash value or a prize of approximately the same retail value. Prizes are non-transferable, must be accepted as awarded by US 92 and cannot be exchanged by a declared winner for cash or other substitutes.

By entering the contest, each entrant agrees to abide by these contest rules, which are subject to change without notice to contest entrants individually, and each entrant releases US 92, its parent, affiliates, subsidiaries, directors, officers, employees, representatives, agents and advertising and promotional agencies, from any damage, loss or liability suffered as a result of or arising from the entrant's participation in a contest or the use of any prize.
16. The contest is void where prohibited by law and is subject to all applicable federal, provincial and municipal laws and regulations. The contest and these contest rules shall be exclusively governed by and construed in accordance with the laws of the state of Nebraska. Any dispute shall be adjudicated in the courts sitting in Madison County, Nebraska.
