

Wishin' for Tuition Give-Away Rules

1. Flood Communications, LLC and Flood Communications of Beatrice, LLC dba as US92 Radio-KUSO-FM and Ol' Red 99.5 – KUTT-FM (hereinafter referred to as the "radio stations") are giving away a \$1500 tuition waiver that has to be used during one semester, for a new traditional student, that has applied and has been accepted as a Wayne State College student. These hours will be applied to 15 credits in the fall semester of 2019.
2. Qualifications for the Wishin' for Tuition contest begins at 8:00am on Monday, November 12, 2018 and ends at 5:00pm on Friday, November 23, 2018.
3. To become a qualifier you must be at least 17 years old and:
 - a. Currently NOT enrolled as a full-time student at Wayne State College
 - b. Apply and be accepted as a Wayne State College student for the Fall Semester of 2019.
 - i. To complete this log on to <https://www.wsc.edu/apply> and apply today
 - c. Complete an online "resume" at US92.com or KWBE.com
 - d. The sender of the resume must identify himself or herself by name, provide an address, phone number and date of birth.
4. Wayne State College will call with the winners of the 2018 Wishin' for Tuition scholarship after all applications are in.
5. No person shall win more than one radio station prize in 30 days.
6. Winner of the contest shall be required to complete any and all documents at the request of either radio station or Wayne State College.
7. Winner may be required to give their Social Security Number for tax reporting purposes.
8. Any person who submits a "resume" to qualify for this contest consents to the radio stations and their sponsors to use his or her, name, their likenesses, and their city of residence on any statements made.
9. Any attempt to tamper with the entry process, interfere with these contest rules, deliberately damage any website or undermine the administration, security or legitimate operation of the contest, is a violation of criminal and civil laws, and the radio stations reserve the right to seek damages and/or other relief from all persons responsible for such acts to the fullest extent permitted by law, which may include banning or disqualifying entrants from this and future radio station contests.

10. The radio stations reserve the rights, at its sole discretion and without prior notice to amend, cancel, close, suspend or reinstate a contest at anytime for any reason. As well as, reserves the right, in their sole discretion, to cancel or substitute any component of a prize for its cash value or a prize of approximately the same retail value. Prizes are non-transferable, must be accepted as awarded by the radio stations and cannot be exchanged by a declared winner for cash or other substitutes.
11. By entering the contest, each entrant agrees to abide by these contest rules, which are subject to change without notice to contest entrants individually, and each entrant releases the radio stations, their parent, affiliates, subsidiaries, directors, officers, employees, representatives, agents and advertising and promotional agencies, from any damage, loss or liability suffered as a result of or arising from the entrant's participation in a contest or the use of any prize.
12. The contest is void where prohibited by law and is subject to all applicable federal, provincial and municipal laws and regulations. The contest and these contest rules shall be exclusively governed by and construed in accordance with the laws of the laws of the state of Nebraska. Any dispute shall be adjudicated in the courts sitting in Madison County, Nebraska.
13. Personal information collected from entrants will be used by the radio stations for the purpose of administering a contest. By entering the contest, entrants consent to the manner of collection, use and disclose of personal information as set out in radio station privacy policy.
14. These rules may be amended from time to time at the sole discretion of the radio station.
